AEJMC MAC Head's Report: Masudul Biswas, Ph.D.

Assessment Meeting Updates:

- MAC was successful in recruiting new and diverse individuals for leadership positions.
- MAC will continue the partnership with the *Howard Journal of Communication*.
- MAC has improved its outreach to its Division members via the development of online communication platforms.
- There is more finesse in the reporting of the Division's annual activities.

Assessment Meeting Recommendations

- MAC might focus on increasing outside-convention activities (for instance, NABJ)
- Consider improving the reporting of such activities outside activities.
- Consider increasing teaching activities such as panels and workshops.
- For example, solicit feedback from social media users on how to write a syllabus.

AEJMC MAC Vice Head's Report: Josh Grimm

Vice Head Josh Grimm, Ph.D., presented the minutes from the 2015 conference. It was moved by Federico Subervi, Ph.D., and seconded by Melita Garza, Ph.D., to accept the minutes as printed. The motion carried.

Report by AEJMC Incoming President Dr. Paul Voakes

AEJMC President Paul Voakes, Ph.D., reported AEJMC has many diversity initiatives in place.

- o The addition of the equity and diversity award has been well received.
- o Members often share brilliant ideas about diversity initiatives.
- o The sharing of best practices is good,
- o Pre-conference workshops are helpful.

What else can be done to address diversity and inclusiveness?

• AEJMC's board resuscitated the Institute for Diverse Leadership. Two of the eight participates have accepted administrative positions.

- International diversity is a concern as are challenges with domestic diversity in the United States.
- Encouraged a conscious effort within interest groups and divisions to help develop leaders.
- Many committees select award winners. Committee members are almost always appointed. This is another opportunity.

CoD Updates

- Overall, paper submissions to all divisions decreased this year.
- The research paper acceptance rate was 49.6% (774).
- A reported 54% of AEJMC members are not a part of any division/interest group.

Membership Report

Total number of members (MACers) as of July 14, 2016:

- In 2015, there were 166 members. In 2016, there 170 members.
- As of June 8, 2016, there were 21 student members,

- Graduate Membership Award recipients will receive free a MAC membership.
- There will be a maximum of 15 new graduate student members each year.

Annual Report Highlights

Trailblazer's History Project: George Daniels

- The project is three years old.
- Need to cover disability, LGBT community and Native Americans.
- Eighteen trailblazers will be interviewed.

- The Native American community has been under-covered.
- There was a panel on the topic at the convention.
- All interviews are housed on the AEJMC website.
- Need to recruit people to do interviews.

Research Reports

Midwinter

- Number of submissions: 16
- Number of acceptances: 14 (only 11 of those papers were programmed since authors of three accepted papers were unable to attend and present their research)
- Excellent opportunity to present research and get feedback
- There was a glitch in reporting demographics, etc.

Faculty Research Paper Competition: Mia Moody-Ramirez, Ph.D.

- The MAC Division sponsored four refereed research sessions, four paper sessions and one poster session at the 2016 AEJMC Conference in Minneapolis, Minn.
- The division had a 50% acceptance rate for both the faculty and student competition.
- There were 24 faculty research paper submissions and 12 acceptances and 12 student research paper submissions and 6 acceptances.

Top Faculty Papers

- First Place: Using media literacy to counter stereotypical images of Blacks and Latinos by Joseph Erba, University of Kansas, Yvonnes Chen, University of Kansas and Hannah Kang, University of Kansas.
- Second Place: Ethnic media as communities of practice: The cultural and institutional identities by Sherry Yu, Temple University.
